

GENERAL PROCUREMENT NOTICE

Equipment for Modernisation of Dosimetric Control Systems and Environmental (Radiation) Monitoring:

- 1 The Science and Technology Centre in Ukraine (STCU) is an international organization involved in the non-proliferation of weapons of mass destruction. STCU's mission is to support research and development activities for peaceful applications by scientists and engineers formerly involved with the development of weapons of mass destruction, to advance global peace and prosperity through chemical, biological, radiological, and nuclear risk mitigation by supporting civilian science and technology partnerships and collaboration that address global security threats and advance non-proliferation.
- 2 The STCU is implementing a number of projects concerning “Modernisation of the Dosimetric Control System in the Exclusion Zone and Environmental (Radiation) Monitoring at the Vektor Complex and the Buriakivka Disposal Facility” funded by a number of donors including the European Union, Norway, United Kingdom and United States of America.
